<ul style="list-style-type: none"> <li>• Provide quality care and support to elderly clients in their home as per care plans.</li> <li>• Ensure documentation is completed as required by policy and procedures.</li> <li>• Ensure all allocated work tasks are completed through effective prioritisation.</li> <li>• Ensure the quality of care and support delivered to clients meets set standards.</li> <li>• Encourage independence and wellbeing of clients with a culture of doing with, not for.</li> <li>• Ensure incidents/events are reported to management as per policy.</li> <li>• Maintain and promote Goodwin's reputation as a quality aged care provider.</li> <li>• Maintain the customer service culture and present professionally to all people.</li> </ul>
